## Rules and Regulations

All entrants are required to comply with the following Rules and Regulations

### Entries

1. The Clun Run Touring Assembly is run by Clowne and District Motor Club MSA Reg.No 120291 under the RAC MSA Certificate of Exemption No (TBA) or Authorisation No (TBA)
2. Entries at a cost of £30 per vehicle open on publication of these regulations and close on the 17<sup>th</sup> June 2017.
3. Entrants do not have to be members of a car club nor be holders of a competition licence.
4. The Run will start at 9:00am and will be limited to a minimum of 15 and a maximum of 65 vehicles. The Tour is open to any road legal, 4 wheeled vehicles of interest. Vehicles with 3 or more than 4 wheel configuration may be admitted but are subject to prior approval by the organisers.
5. Heavily modified or sign written completion style vehicles may be accepted at the organisers' discretion. Prospective entrants of such a vehicle should contact the organisers before entering.
6. The organisers reserve the right to cancel the event if the minimum number of entries is not reached by the closing date.
7. Vehicles will be identified by registration numbers and by a Tour Plate issued by the organisers only. No additional competition numbers are allowed.
8. All vehicles must have current tax, insurance and VOSA M.o.T. (unless the vehicle is exempt from the MoT requirement because of age). The driver will be required to sign a declaration to this effect. "Trade Plates" are expressly prohibited. Th
9. Each driver will hold a relevant driving licence entitling them to drive the class of vehicle entered.
10. Each driver will carry with him/her on the day – a valid driving licence, a current VOSA M.o.T. certificate (if required) and an insurance certificate giving a minimum of third party insurance cover. These documents must be produced at signing on if requested or entry will be refused.
11. All entrants must be the registered keeper of the vehicle or the formal representative of the registered keeper and take full responsibility for all legal compliance both on and off the highway.
12. Cancellation of an entry, in writing, before the closing date will result in a full refund. Refund in respect of cancellation under any other circumstances is at the discretion of the organisers.

### Route

13. Start times given in the Final Instructions.
14. Other than a start time, mid tour suggested re-start and a finish control final closing time, there will be no timing involved on this event. The average speed required to reach the finish before the control closing time will be such that a relaxed pace is required to complete the route in time.
15. Cars will follow a route of approximately 100 miles on public roads. The route will be defined by a series of tulip (Junction) diagrams which will be detailed in a road book given to each crew at signing-on. At approximately half distance there will be a refreshment halt at where you will be directed to a dedicated parking space. You will start from this venue at the approximate re-start time given in your final instructions and return via the tulip diagrams to the finish.
16. Participants will have the opportunity to take part in a quiz which may involve for example making a note of code boards passed along the route. This is not mandatory and no prize will be given.
17. Drivers are responsible for their own and any passenger's behaviour, both on and off the highway, and all will abide by these rules and regulations and the organisers' and marshals' instructions. Failure do so may result in confiscation of the road book and exclusion from the Tour. Under these circumstances NO refund will be given.
18. At the start, halfway halt and finish venues and throughout the Tour, all entrants will observe any instructions or orders given verbally by the landowner's security people or marshals as well as road markings, speed limits or direction signs.

### Driving Standards

19. This is not a race rally or time trial. Drivers should at all times observe the relevant highway law and drive in a courteous and safe manner. The organisers reserve the right to deal with inappropriate driving in a proportionate manner as they see fit.

### General Information

The Final Instructions will be posted/emailed to you not later than 7days before the Run.

The entry fee includes a hot sandwich breakfast and buffet meal for the driver and one passenger. Additional meals may be purchased at the time of entry only. Additional meals will not be available on the day unless ordered and paid for in advance.
